Mr. Russell made the motion and a second by Mr. Brown approved minutes from the October regular meeting. All Trustees voted yes.

Mr. Russell made the motion and a second by Mr. Brown to approve bills for \$57,566.31 covered by e-payments E150-E-186 and Warrants 21336-21370.

Public Comments: Mr. and Mrs. Wood started the discussion regarding their neighbor @ 6592 West Maple Ave, stating that they have been living by this neighbor, that may have a drug problem or have mental health issues due to activities that he demonstrates. They believe the house is inhabitable and are notifying the township of these activities because they do not know what else to do. The Sheriffs Department is aware of this neighbor and has been there many times. Zoning will contact the owner regarding any property maintenance issues.

Fire Department: No report given

Zoning Report: Mr. Cerjan state that the Tiny House on Wheeler Creek has sold and renewed the building permit. Mr. Cerjan stated that Terry was contacted regarding the septic tank issue and Mr. Cerjan didn't charge for the permit since he felt it was the county fault. Mr. Cerjan received a complaint on Padnarum Road @ Grimmitt Property regarding construction materials that needed to be disposed. The tires on Wheeler Creek Road is being addressed and is taking care of the removal. No current activity on Dollar General Store.

Road Department: Mr. Russell stated that they are reviewing budget and they have requested an air compressor for \$3000.00 and Plasma cutter for \$1200.00 to purchase. A motion from Mr. Russell and Second by Mr. Mills. Both trustees voted yes.

Fiscal Officer Report: Mrs. Huff stated she received information regarding applying for the NOPEC grant for \$1500.00. It was decided after discussion that the funds should be donated to Geneva Safety Forces Share a Christmas Program. A motion by Mr. Mills and a second by Mr. Russell. Both Trustees voted yes.

Mrs. Huff presented Resolution 2020-09, 2021 Annual appropriation's, Mr. Russell made the motion, Mr. Mills second. Both trustees voted yes.
